Welcome to the 2nd running of the Teakle Auto Sprint Port Lincoln.

We wish to build on the great success of the first event, so we will keep the relaxed and friendly atmosphere in our pit area with the continued public access, however we will also be promoting that winning on the track is a serious and sort after prize.

Competition will be similar to last year with the tighter 750m course on Saturday and the longer 1500m course on Sunday. With accumulated times over the two days, this gives a great opportunity for all categories of cars to do well in their class and possibly overall.

There have been some minor track enhancements to open up some of the tight hairpin turns. Entry at turn 1 on Saturday is two metres wider and the last hairpin before the finish line is a metre wider (every bit helps). Barriers have been removed from the centre of the road at turn 1, making this better for the return run on Sunday.

One of the unique elements of the Teakle Auto Sprint is the wide variety of cars that compete. Whether its dirt or tarmac rally, circuit or hill climb cars we encourage your entry. We also have limited space for non-log book cars. The variety is great for the hard-fought competition and a wonderful experience for spectators.

In 2018, please be aware that the pit/paddock area will only be on the foreshore lawns in 2018.

1 EVENT SUMMARY

Article 1.1 - EVENT SUMMARY

THESE REGULATIONS ARE TO BE READ IN CONJUNCTION WITH THE CURRENT CAMS MANUAL OF MOTOR SPORT AND ANY FURTHER REGULATIONS, BULLETINS OR INSTRUCTIONS ISSUED BY THE ORGANISERS.

1.1.1 The event will be held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, the Speed Event Standing Regulations, the CAMS Passenger in Vehicle Guidelines, these Supplementary Regulations, Further Regulations and any Bulletins or Instructions to competitors that may be issued.

1.1.2 Where there is any divergence between the current CAMS Manual of Motor Sport and these Event Supplementary Regulations, the current CAMS Manual of Motor Sport will take precedence.

1.1.3 The 2018 Teakle Auto Sprint, hereinafter referred to as 'the event'

- Will use electronic timing to 0.01 second.
- Is approved to run by CAMS.
- The event will be a multi-club, speed event comprising of timed sprints conducted on two courses, held on sealed (bitumen) closed public roads at Port Lincoln, SA, on Saturday 31st March and Sunday 1st April 2018.
- Membership to the EP Autosports Club is also available, contact the Event Secretary for details.
- The event is open to all vehicles that comply with Schedules A and B of the current CAMS Manual of Motor Sport. Category 1 vehicles are not permitted.

1.1.4 The CAMS Permit Number authorising the event is **518/0104/01**

1.1.5 The course to be used on Saturday is approximately 750 metres in length. The course to be used on Sunday is approximately 1500 metres in length. Times will be accumulated over the 2 days.

1.1.6 Crews involved in accidents resulting in property damage are advised that they may be required to pay up to the first \$1000 of any claim to rectify such property damage. Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

Article 1.2 Sponsor/Official Rides:

During Breaks between competitive activities EVENT SPONSOR and EVENT OFFICIAL Appreciation rides may take place.

1.2.1 Participation in these activities will be by **invitation only** from the Event Organisers.

1.2.2 All relevant Documentation relating to Passenger in Vehicle Experiences is to be completed by **ALL** Drivers and **ALL** Passengers prior to the activity commencing. This event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the CAMS MSPRA Policy

1.2.3 Minimum Licence requirement for the Driver is Clubman Rally (CR) or Clubman Circuit (CC) and current civil drivers licence.

1.2.4 Drivers are to be briefed separately to the Event Drivers Briefing and prior to the Activity commencing

1.2.5 Passengers are to be briefed immediately before the activity commences.

1.2.6 Only vehicles that comply to Schedule R of the current CAMS Manual of Motor Sport, "General Requirements for Rally Cars" are eligible for Sponsor/Official ride activities

1.2.7 Vehicles must complete Scrutiny prior to the activity commencing.

1.2.8 Clothing and Apparel requirements for this activity is as per Article 6.1.2 of these Supplementary Regulations

5 JUDGES OF FACT

Article 5.1 - JUDGES OF FACT

In accordance with NCR 181 the following officials are deemed to be Judges of Fact ➤

Officials of the event are deemed to be Judges of Fact of the following

- Not wearing seat belt, helmet or safety clothing
 - Service Park infringements
 - Shortcutting the course
- Scrutineers are deemed to be Judges of Fact of the following:
- Vehicle in un-roadworthy condition
 - Oil leaking from vehicles
 - Vehicle with accident damage
 - Eligibility of Vehicles
 - Driver Apparel
 - Dorian placement
- Medical Officers are deemed to be Judges of Fact of the Medical condition of ▪ Any crew member or team member.
- Speed Monitoring Officials using suitable equipment are deemed to be Judges Fact to the Speed
- Of a competing vehicle or service vehicle.

6 COMPETITOR ELIGIBILITY

Article 6.1 - COMPETITOR ELIGIBILITY

6.1.1 Licences:

The driver shall hold, as a minimum, a current CAMS Level 2S, Level 2SJ Licence or equivalent 'Single Event' Licence (L2SE). Single event Licence application forms are available from the event organisers and can be completed prior to the events close of entries. Minimum age for competitors is 16.

6.1.2 Clothing and Apparel:

- 6.1.2.1 Safety helmets, as to AS1698 standard (or otherwise to the standard listed in Schedule D of the current CAMS Manual of Motor Sport) are mandatory.
- 6.1.2.2 Clothing of a non-flammable material shall extend from neck to wrist and ankle. Shoes with a leather upper or of a better standard (e.g. racing shoes to FIA standard) must be worn.
- 6.1.2.3 All open Sports and Racing Car drivers must wear goggles or a visor to AS 1609/1981. Goggles with glass lenses, whether laminated or not are unacceptable.
- 6.1.2.4 Frontal Head Restraints, driving suits and gloves are recommended but are not mandatory. All apparel shall be in accordance with Schedule D of the current CAMS Manual of Motor Sport.

The Organisers reserve the right to review and exclude any driver who has been identified in the past or during the event in any officially observed incidents that bring the sport into disrepute, either prior or during the event.

Article 7.1 - VEHICLE ELIGIBILITY

Entries will be accepted for the following classes:

Road Registered Vehicles

0-2000cc
2000cc-4000cc
4000cc and over
4WD up to 3500cc
4WD over 3500cc

Road Registered Vehicles can use semi slicks (legal for road use) but not racing slicks Can use different turbo and intercooler.

Can have half cage or hoops behind the driver's head

Race & Rally Cars (this class is for dedicated competition vehicles)

0-2000cc
2000cc-4000cc
4000cc and over
4WD up to 3500cc
4WD over 3500cc

In the case of insufficient entries in any class, i.e. fewer than 3, the class may be amalgamated with the next highest class in the same group (i.e. the class above).

All competing vehicles must comply with **SCHEDULE A** and **SCHEDULE B** of the current CAMS Manual of Motor Sport

All competing vehicles shall carry a properly affixed Fire Extinguisher complying with the provisions of Schedule H of the current CAMS Manual of Motor Sport. Vehicles must be adequately muffled to comply with noise restrictions.

8 DRUGS IN MOTORSPORT

Article 8.1 - ALCOHOL, DRUGS AND OTHER SUBSTANCES

8.1.1 All Competitors and Pit Crew Members are reminded of the CAMS Anti-Doping policy in the Current CAMS Manual of Motor Sport (General Regulations).

8.1.2 Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

9 RUNNING OF THE EVENT

Article 9.1 - RUNNING OF THE EVENT

- 9.1.1 The driver **MUST** be present at Competitors' briefing at **0900 hrs on 31st of March 2018 at a location to be issued in a bulletin closer to the event.** Non-attendance will be a penalty of refusal to start.
- 9.1.2 The Event will start at **1000 hrs on Saturday 31st March 2018** and the last car will finish on **Sunday 1st April 2018** at approximately **1730 hrs.**
- (a) The event will comprise of a minimum of 4 runs over the Saturday course and a minimum of 4 runs over the Sunday Course.
 - (b) Each driver will be offered the opportunity to drive through each course on the relevant day prior to any competition, during an untimed and speed-limited reconnoitre (reconnaissance) activity.
 - (c) For the purpose of establishing order of merit, the time recorded by a driver for all runs, for which the entire field (less any retirements) has the opportunity to participate in, will be aggregated. The driver recording the lowest aggregate time will be declared the winner.
 - (d) Any competitor that fails to start a run (DNS) or finish (DNF) a run will be given a derived time of 2 minutes as their result for the incomplete run.
 - (e) On the reconnoitre activity, helmets do not need to be worn, but other normal minimum speed event apparel must be worn (e.g. no shorts or tee shirt etc.).
- 9.1.3 Cars may start only at the discretion of the Starter and Clerk of Course.
- 9.1.4 RE-RUNS Re-runs will only be permitted under the following circumstances:
- (i) failure of timing equipment.
 - (ii) if a Red Flag is used to stop a run and the drivers have not completed the run, or if you are slowed by the car in front. If you are the cause of a red flag, then you will not be offered a re-run. All times recorded in the re run are to count towards the results.

10 CHANGES CREATED BY CIVIL AUTHORITIES

Article 10.1 - CHANGES CREATED BY CIVIL AUTHORITIES

- 10.1.1 These Regulations are issued subject to any provisions made mandatory for the conduct of the event by the relevant civil authorities between the date of issue of these Regulations and the conduct of the event.

11.1.2 The entry fee for the Event is fixed as follows:

- Competitors have **30 days** after receiving confirmation of acceptance of entry to make full payment before their place is offered to the next available competitor. Acceptance of entry will still be made by the Teakle Auto Sprint Pt Lincoln Committee.
- All entry fees must be paid by close of entries on **Friday 16th February 2018**

Entry Fee is \$550 inc GST, with a deposit of \$150 to be paid on entering. The remaining \$400 is to be paid upon the acceptance by the organising committee of your entry.

11.1.3 The organisers reserve the right to cancel or postpone the event in accordance with NCR 59 of the current CAMS Manual of Motor Sport, should the number of entries be less than 50 or due to circumstances which result in force majeure. Maximum limit of entries is 80 which includes 5 wildcards by the organising committee. If the maximum number of entries is received, then a reserve list will be formulated. 2 entries are reserved for the organising committee.

12 PITS AND RE-FUELLING

Article 12.1 - PIT AREA AND RE-FUELING

- 12.1.1 There will be no refuelling in the lawned pit area. Cars may be re-fuelled on the Northern end of Tasman Terrace when the team supplies its own fire extinguisher and official.
- 12.1.2 The speed of cars in the service park must not exceed 10km/h; offenders will be reported to the Stewards of the Event, who will decide on a penalty.
- 12.1.3 Fuel shall be in accordance with Schedule G of the current CAMS Manual of Motor Sport.

13 DOCUMENTATION AND SCRUTINY

Article 13.1 - DOCUMENTATION AND SCRUTINY

- 13.1.1 Documentation will be available during the following times and must be completed prior to presentation of that vehicle for scrutiny – 1200 hrs to 1700hrs on Friday 30th March 2018 or Saturday 1st April 0700hrs to 0900hrs at the corner of Eyre Street and Tasman Street.
- 13.1.2 Vehicles must be presented for scrutiny either 1200 hrs to 1700hrs on Friday 30th March 2018 or Saturday 31st March 2018 0700hrs to 0900hrs at the corner of Eyre Street and Tasman Street. Vehicles are required to be presented to the scrutineers in a clean state with no oil leaks.
- 13.1.3 Documents to be presented at documentation include:
- CAMS Competition Licence
 - CAMS Automobile Log Book (if the vehicle has one)
 - CAMS Affiliated Club Membership Cards
 - Registration/Permit papers for road registered cars.
 - Civil Drivers Licence.

All documents presented must be current & not expire over the duration of the event.

- 13.1.4 The Driver **MUST** be present at documentation.
- 13.1.5 Any competitor who fails to meet vehicle re-presentation requirements as directed will be refused permission to start the event. Entries may be refused in accordance with NCR 83 of the current CAMS Manual of Motor Sport.

14 PROTESTS

Article 14.1 - PROTESTS

- 14.1.1 Protests, if any, must be lodged in accordance with Part XII of the NCR. Protests relating to the eligibility of an automobile shall be made within 30 minutes of the completion of the competition activities.

Article 15.1 - RESULTS

15.1.1 Where a driver has stopped or has been slowed during a heat to render assistance to another crew after an accident or slowed due to a car on the racing line, then that crew will be given a re-run at the most convenient time at the Clerk of Courses discretion.

Results will be based on accumulated times. There will be two separate heats, Heat 1 on Saturday and Heat 2 on Sunday. The winner of the event will be the lowest time including penalties over the two heats.
